Stops will include a high school to housing redevelopment and a nutraceutical manufacturer the community attracted and has helped expand.

1) How Economic Developers Can Utilize Brownfield Grants

Navigating the Brownfield grant application process can be daunting. Jacob Rohter from Kansas State University's TAB program, and Mel Pins, Executive Officer for the lowa Department of Natural Resources, will help educate the audience in how Brownfield grants can benefit their towns. Daniel Green, an Environmental Project Manager with Terracon Consultants, Inc., will discuss the environmental impacts.

As an example, the panelists will discuss how the city of Coralville, lowa used Brownfield grants to redevelop several properties that were eyesores. For more than a decade, Coralville has been able to innovatively use Environmental Protection Agency (EPA) Brownfield funding to enhance the city's redevelopment success. Coralville has won 14 highly competitive EPA Brownfield grants. These grants have allowed the city to redevelop the lowa River Landing, hotel and conference center, and a medical center. Coralville has won both regional and national EPA awards, including a 2007 EPA Phoenix Award, and recognition from the U.S. Conference of Mayors. A total of 6.27 acres have been made ready for reuse.

2) The Robots Are Coming: The Positive Impact of Automation on Rural Manufacturers Location: Dodge Meeting Room

When a rural community hears that a local manufacturer is automating the first thing they think is – we are going to lose jobs! That is far from the truth. Automation doesn't mean job loss, automation can transform physically demanding, stagnant, repetitive jobs into technical jobs that require the upskilling of employees and a means for people to advance their careers. It also means making the company more productive and able to be competitive in the global marketplace. In this session you will hear from two manufacturers and an automation technology provider as they discuss the why and how of their automation stories and the impact on rural communities.

3) Metrics that Matter

As a former economic developer plus part-time economic development nerd, one subject that I am passionate about is the need to change the metrics associated with economic development. For over 100 years, economic development success has been measured the same way as jobs and capital investment. It is long past time to move the economic development profession towards an industry that measures the true impact of successful economic development. The need to report on actual versus announced as many times the actual figures are more over time. Let's talk about measuring poverty levels, workforce participation, taxes generated, or taxes saved...the true value of economic development is more than an announcement. By changing the measurements, the story widens, and the understanding of economic development is deepened.

As the United States continues to move rapidly toward carbon-free energy resources, the burden for hosting utility-scale wind and solar generation facilities is falling largely on rural communities – even as the energy itself is often exported to population centers hundreds of miles away. For many reasons – from protecting agricultural heritage to preserving viewsheds to simply NIMBY-ism – those rural communities are starting to push back, imposing moratoriums on new projects, enacting strict permitting requirements and embracing grassroots campaigns to oppose the projects altogether. But the benefits of saving the planet, fortifying our electric grid and bringing jobs and taxable infrastructure to rural areas and their residents are compelling for struggling small towns and remote counties. So what's a responsible economic developer to do? The experts on this panel will discuss



the various considerations you should weigh when assessing the impacts of proposed renewable facilities, the role you can play in helping your community make decisions and the most pressing questions you should be asking both proponents and opponents of any particular project.
